It is an honor and a privilege to be elected to the Board of Directors of the Florida Justice Association®. A director has responsibilities to the Board and to the Association's members to make a meaningful contribution to the work of the Association. Such contribution involves setting an example of leadership, committing time and energy to the Association's activities and providing personal and financial support as required.

In order to encourage and guide both existing and new members, the Board has established the following minimum standards expected of Board members. **Current board members who are running for re-election had the following responsibilities:**

1. **Recruit 3 New EAGLEs:** EAGLE® members provide funding over and above membership dues to help support FJA's legislative advocacy program.  
  
**Note:** All Board members must be current EAGLE members of the FJA®.
2. **Recruit 2 New or Lapsed Members:** Board members are required to bring in 2 new FJA members each year. These can be either new members or members whose membership has lapsed.
3. **Legislative Service Requirement:** During legislative sessions or legislative committee weeks, each Board member shall be responsible for lobbying 3 days per year, or provide other legislative resources, research, key contact, etc. for an equivalent time commitment.
4. **Legislator Relationship Building:** Each Board member is encouraged to develop a relationship with his or her Representative and/or Senator. This is a critical component of FJA's Key Contact Program.
5. **Write or Raise Funds (\$10,000) for FJ PAC® per Election Cycle:** These funds help support justice friendly candidates and political operations during the election cycle and are critical to our legislative success.
6. **Attending all Board Meetings unless excused in accordance with current attendance policy:** Every Board member shall attend each annual and special membership meeting and each regular and special Board meeting. If a Board member misses 3 meetings in one year without furnishing valid written reasons or the Board disapproves the reason(s) then the Board member is removed from office.
7. **AAJ Membership:** All Board members shall be members of the American Association for Justice (AAJ). Additionally, contributing to AAJ-PAC is encouraged.
8. **Business Friend Introductions:** Board members are to sign-up and participate in two (2) virtual Business Friends of EAGLE introductions.

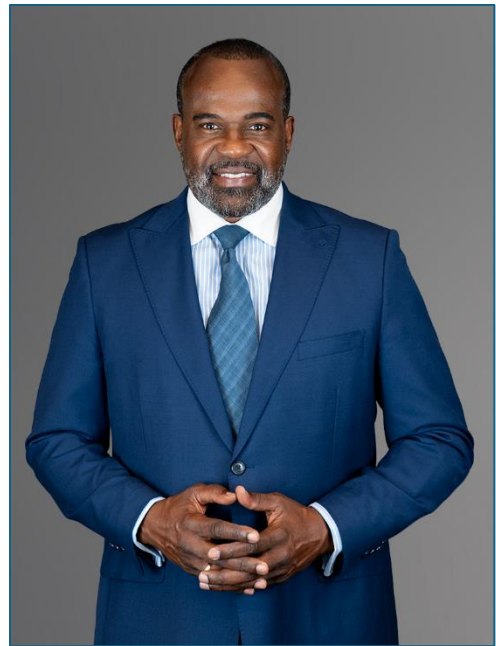
